1. What are the goals?

1) Create a **multi agency structure**:

- before release
- to ensure follow-up
- to unify the efforts of reintegration in the transition from prison to community
- To minimize the risk to society


2) Design specific **intervention** for inmates who:

- have committed crimes related to terrorism.
- during his stay in prison, significant indicators of radicalization have been detected.



Create an holistic structure and working procedures in order to prepare for reintegration and resocialisation with society.

Three levels of the project:



Coordination

Analysis



2. What are the activities undertaken to produce this outcome?

Creation of a multi agency structure

- ❑ Identify **actors**
- ❑ Elaborate a operating protocol of the multiagency that must have:
 - ❑ the **mission** of the multiagency .
 - ❑ a clear-cut agreements a bout respective **roles** and limitations for all actors.
 - ❑ the **working processes**, specially for:
 - ❑ **Information sharing**
 - ❑ **Decision making**
 - ❑ the **frequency/place** of the meetings.
 - ❑ the **flow** of information.
- ❑ Organize a y **first meeting** of the multiagency to explain the previous points (inviting Efus and maybe a professional who can create debate and reflection on the multi-agency space).
- ❑ **Train** with a unique case that has currently entered by indoctrination.

2. What are the activities undertaken to produce this outcome?

Intervention: the intervention program desirable must fit into the rehabilitation model of Catalan prisons:

- ✓ Based on cognitive behavioral theory and practice
- ✓ Structured, clear and managerial.
- ✓ Of adequate duration and intensity.
- ✓ Priority: to change learning styles and skills.


