Study	Criterion	Clinical judgement	Structured judgement
Grove et al. (2000)	general mix	6% better	47% better
Bonta, Law & Hanson (1998)	general recidivism	AUC=0.50	AUC=0.73
	violent recidivism	AUC=0,55	AUC=0,64
Hanson & Bussière (1998)	Sexual recidivism	AUC=0,56	AUC=0,74
Mossman (1994)	Violence	AUC=0,67	AUC=0,78
Andrews, Bonta & Wormith (2006)	General	AUC=0,56	AUC=0,75
	violence	AUC=0,57	AUC=0,73

- What works? → risk, needs, responsiveness
- Based on OASys (England & Wales)
- Adapted to Dutch situation
- Implementation: 2004/2005
- Research: reliability (2007), validity (2009)
- Structured way of supervision and sentence planning (2010)

**RISc of recidivism**

**79 =  
Medium high**



- Recidivism (RISc, Static 99)
- Self harm
- Seriousness offence
- Harm to other people
- What people: known or unknown
- Breach / non-compliance
- Specific location
- Specific time
- Imminence

Automatic conclusion and professional opinion

- Offender concerns (self assessment)
- Motivation
- Possibility for change
- Strengths
- Weaknesses



## 1. Reliability / construct validity

- Inter-rater reliability good, except scales 11 and 12
- Internal consistency: good, except scales 6 and 9
- Predictive validity, RISC scores compared to Statrec (Dutch version of OGRS): good, but less good for female offenders and older offenders (> 50 years)

## 2. Predictive validity

- AUC 0,70 (general recidivism, 2 years follow up)
- Less good for: sex offenders, persistent offenders, first offenders

## Goal:

- Structured
- Transparent
- Link between conclusions on risk, needs, responsibility and supervision and sentence plan
- Reliable
- Workable
- Valid

- Aggression regulation
- Drug/alcohol abuse (general or short)
- Labour skills
- Living skills

Automatic indication based on selection criteria

- Education
- Jobcentre
- Debt assistance
- Health care
- Psychiatric care
- Care for intellectual disabled
- Housing facilities
  
- Support by probation officer

On each criminogenic need with a priority:

1. Goal
2. Intervention
  - a. Automatic
  - b. Professional
3. Setting
4. Practicable
