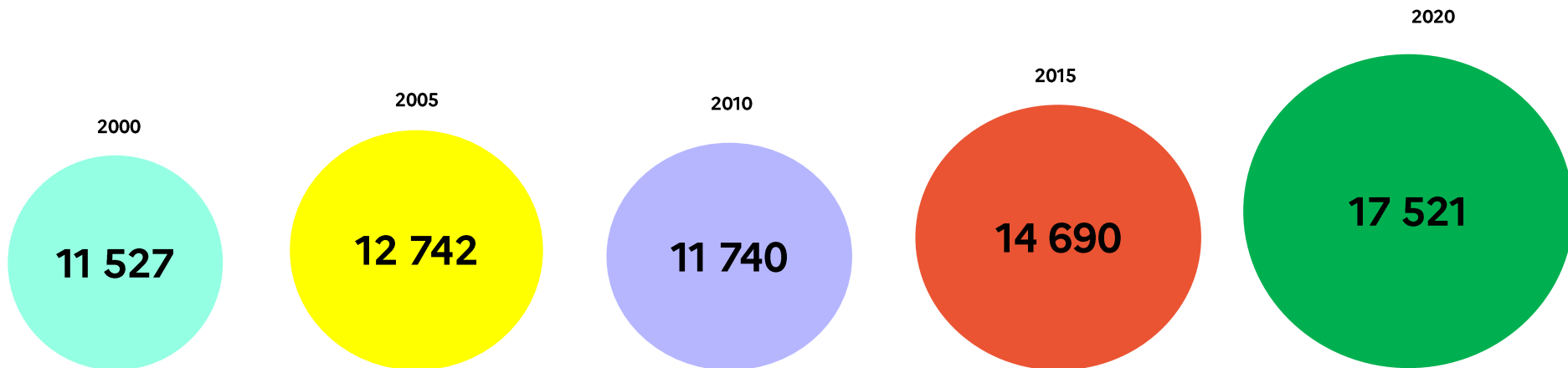

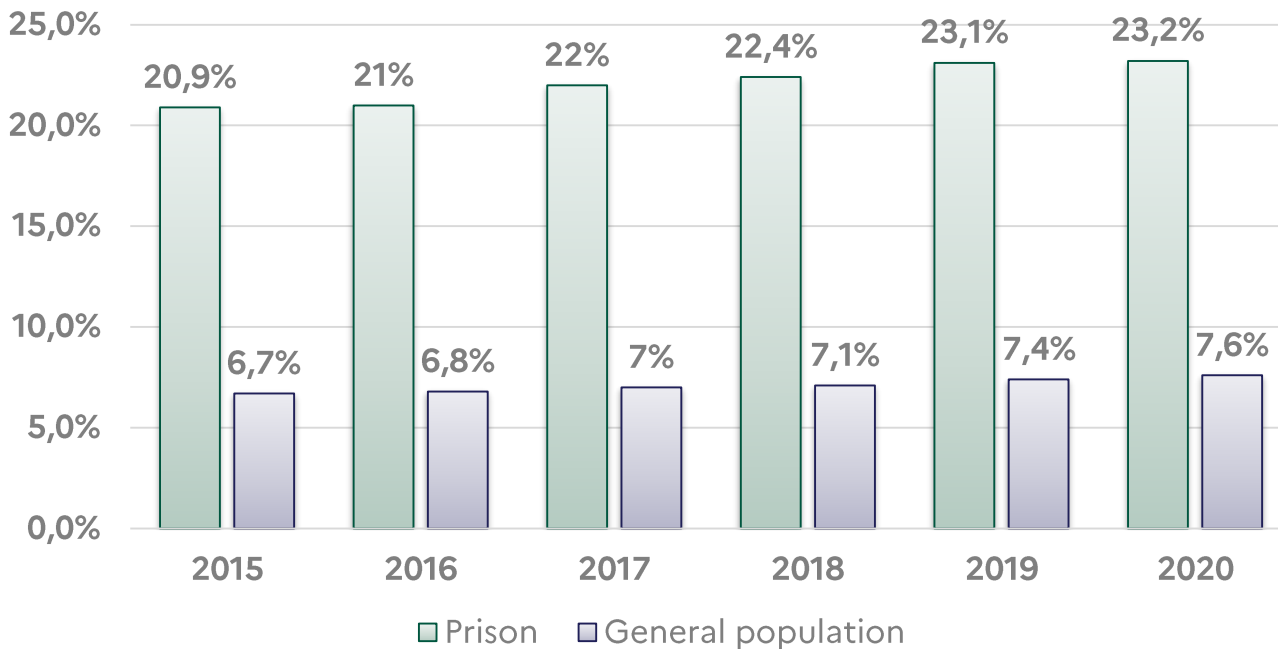
Between 2000 and 2020, the number of foreigners held in prison has increased about 1.5 times. Over the first ten years of this period of time, this number was relatively stable.

% of foreigners in general population vs % of foreigners held in prison



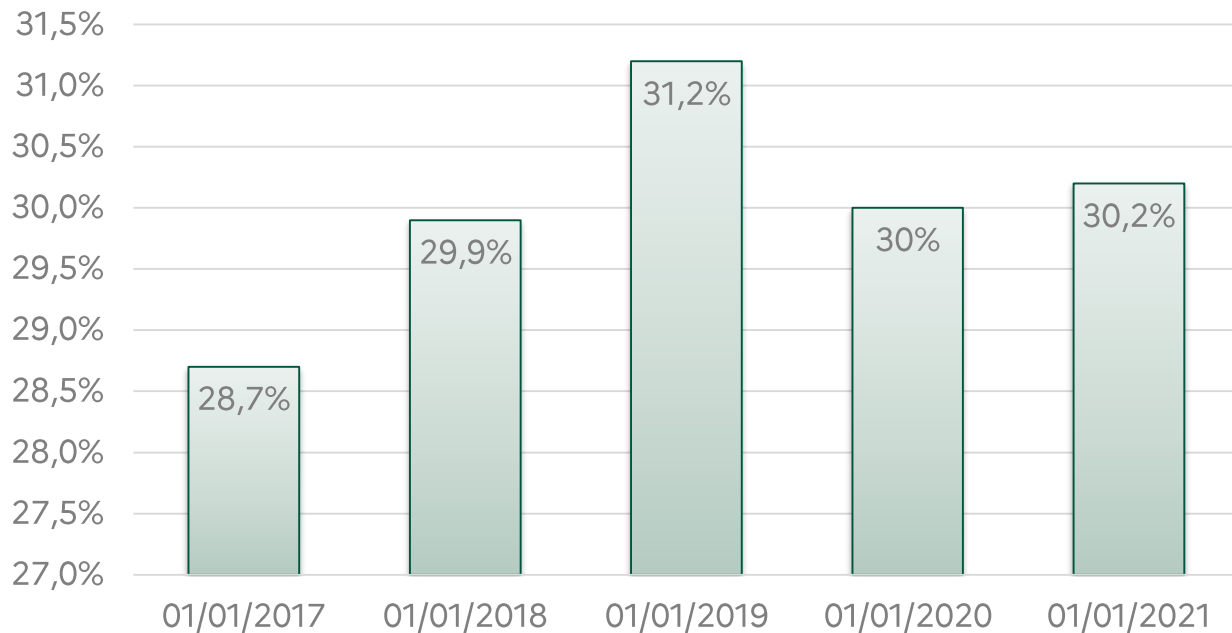

% foreigners among pre-trial detainees



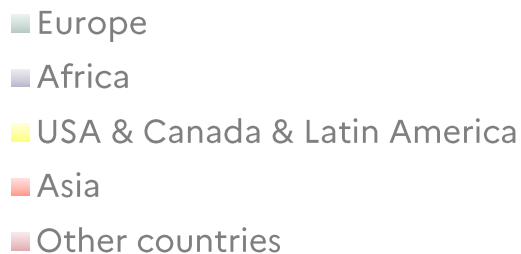
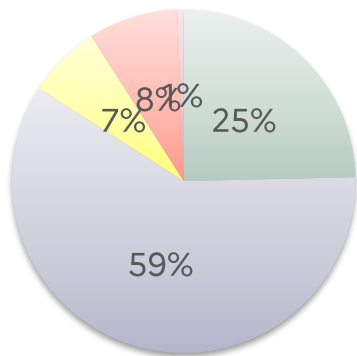

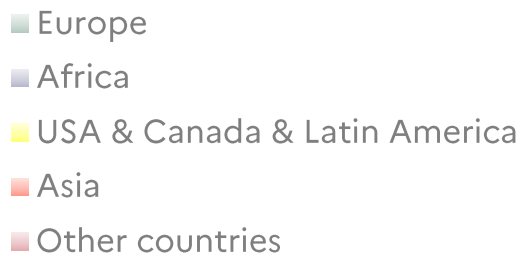

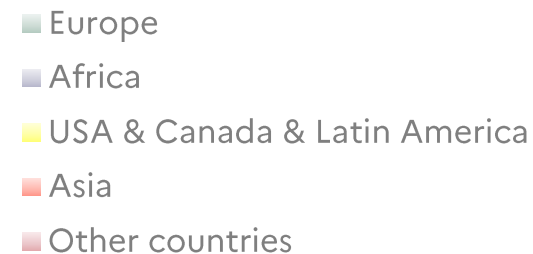
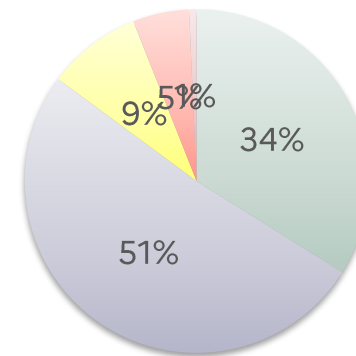

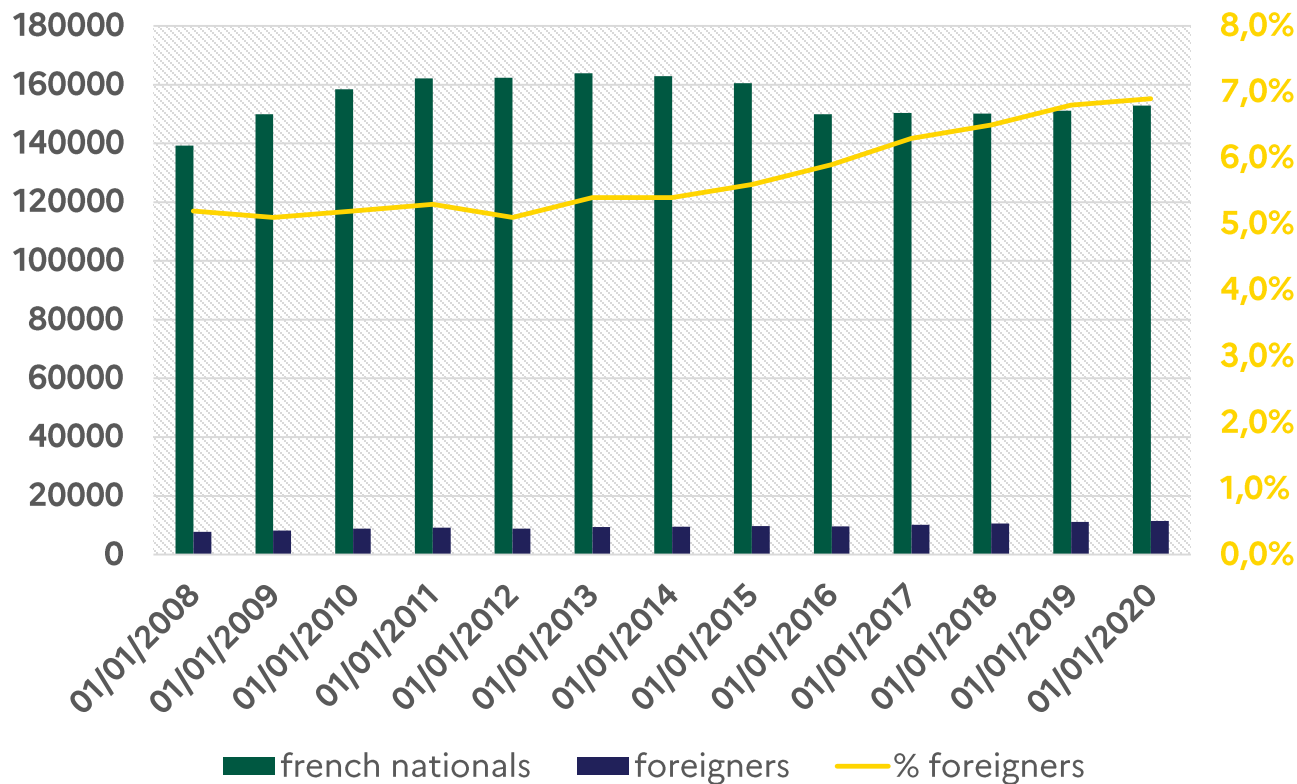

Foreign nationals are underrepresented in community sanctions and measures

- **Protocol to issue of residence permits for those whose permits expired during imprisonment.**
- **The removal of foreign detained persons in an irregular situation following the completion of the sentence (co-ordinated approach).**
- **Relations of foreign detained persons with their consular authority.**

Regarding the supervision of probation measures and alternative sanctions
