PROBATION TASKS

1. reports for prosecutors (settlement proceedings),
2. reports for prosecutor (suspended prosecution),
3. compensating and settling the damage (suspended prosecution),
4. reports for courts, when deciding about the sentence
5. **suspended sentence with custodial supervision, → MOST COMMON FOR DV perpetration**
6. release on parole under custodial supervision,
7. house imprisonment,
8. work for general benefit,
9. cooperation with prisons – planning release on parole under CS

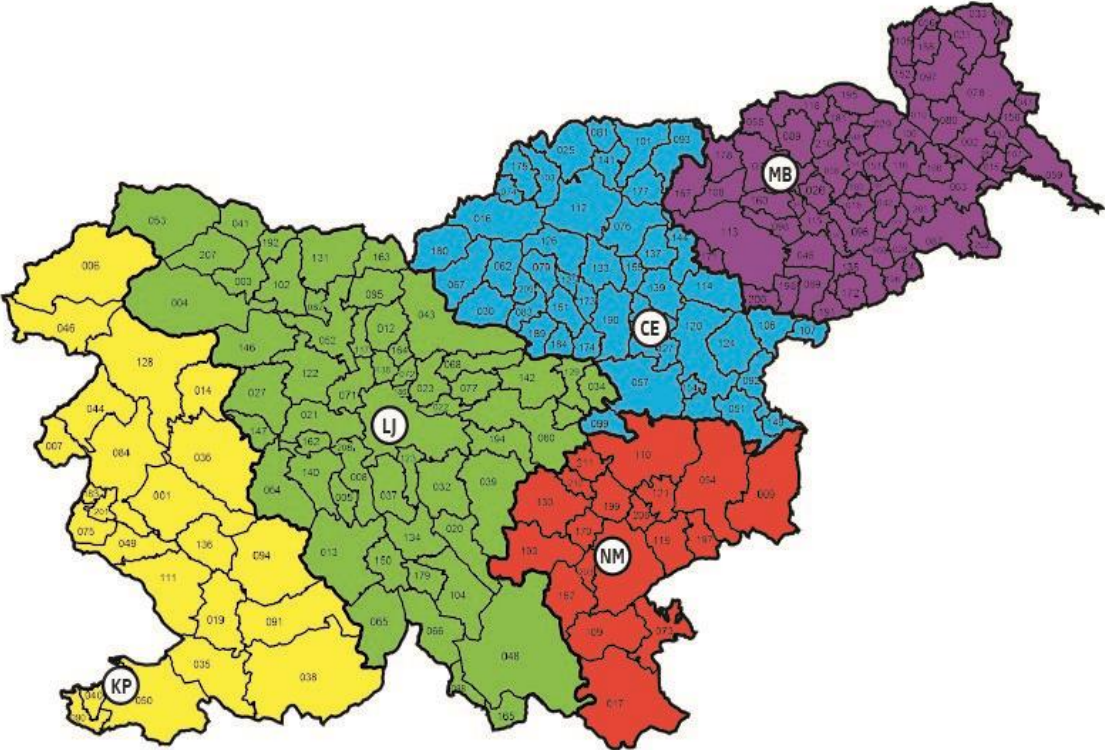
PURPOSE: Identifying and eliminating the causes that influenced on commitment of criminal offence, assistance in addressing personal problems, assistance in arranging living conditions and establishing acceptable forms of behavior



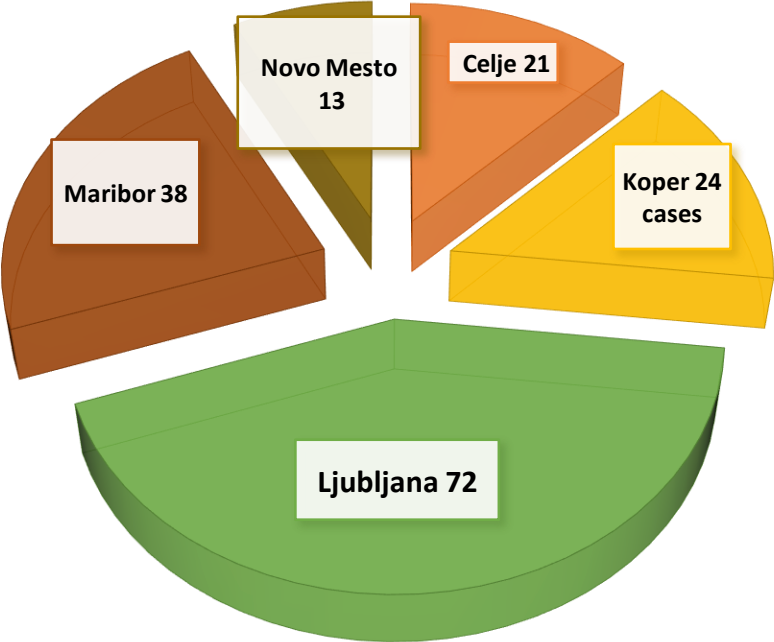
Probationer OF DV in 2019

- Domestic violence in criminal act of 191. Article of Criminal Code (KZ-1, Republic of Slovenia).

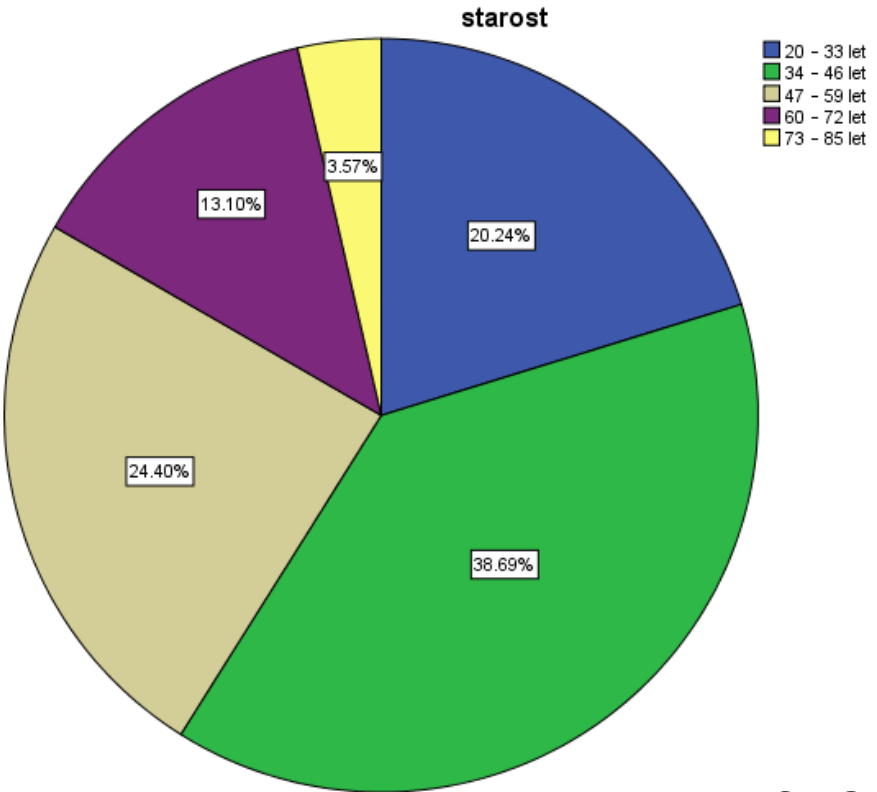
Analyze by region



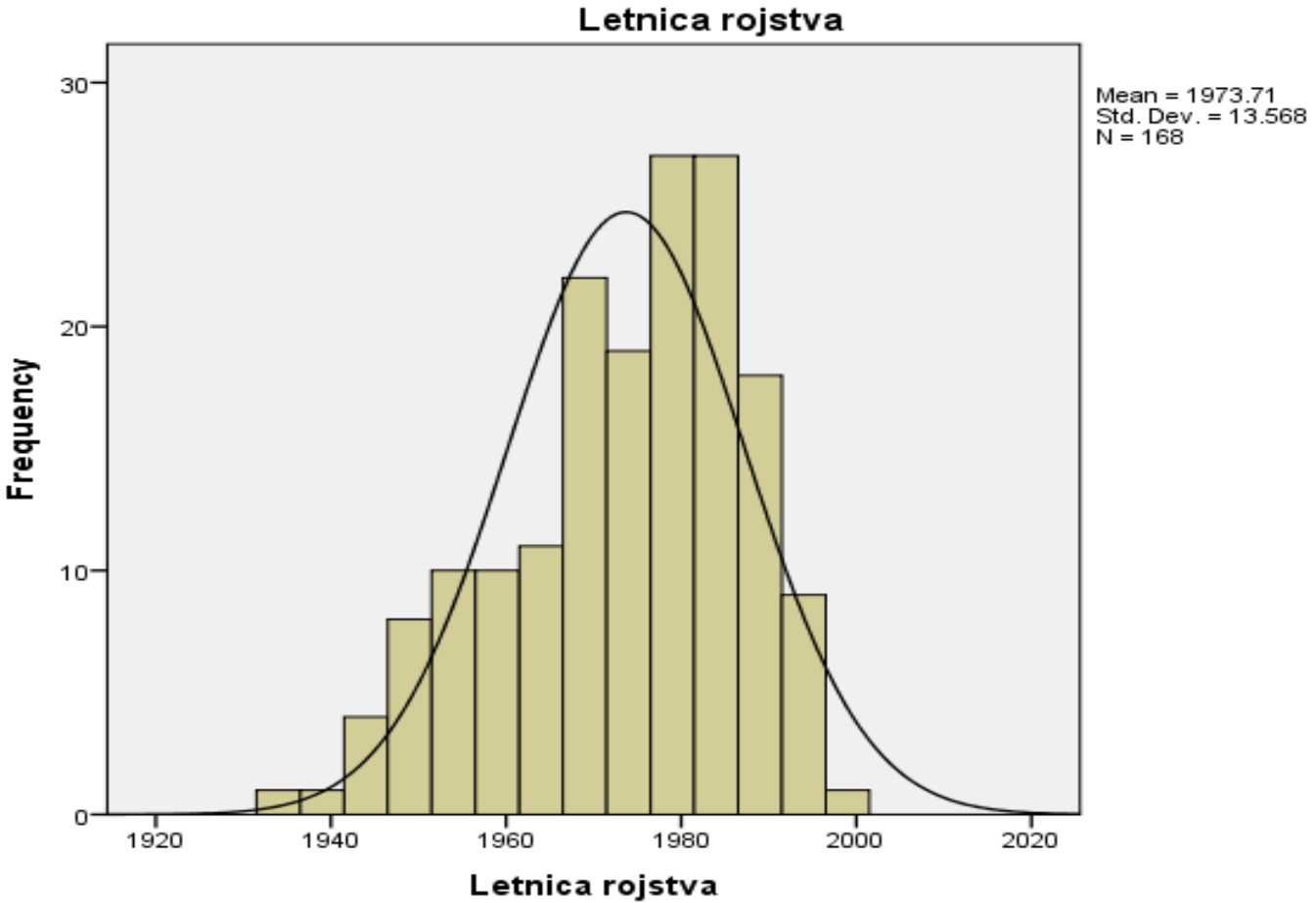
TREATMENT BY REGION



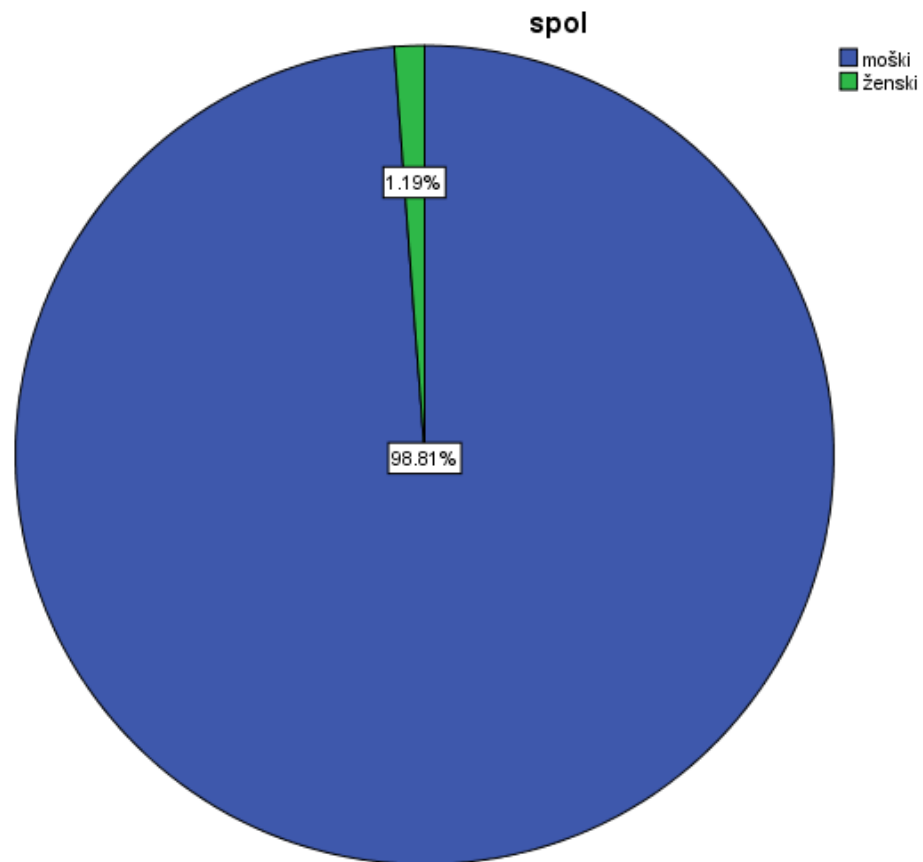
Analyze by age

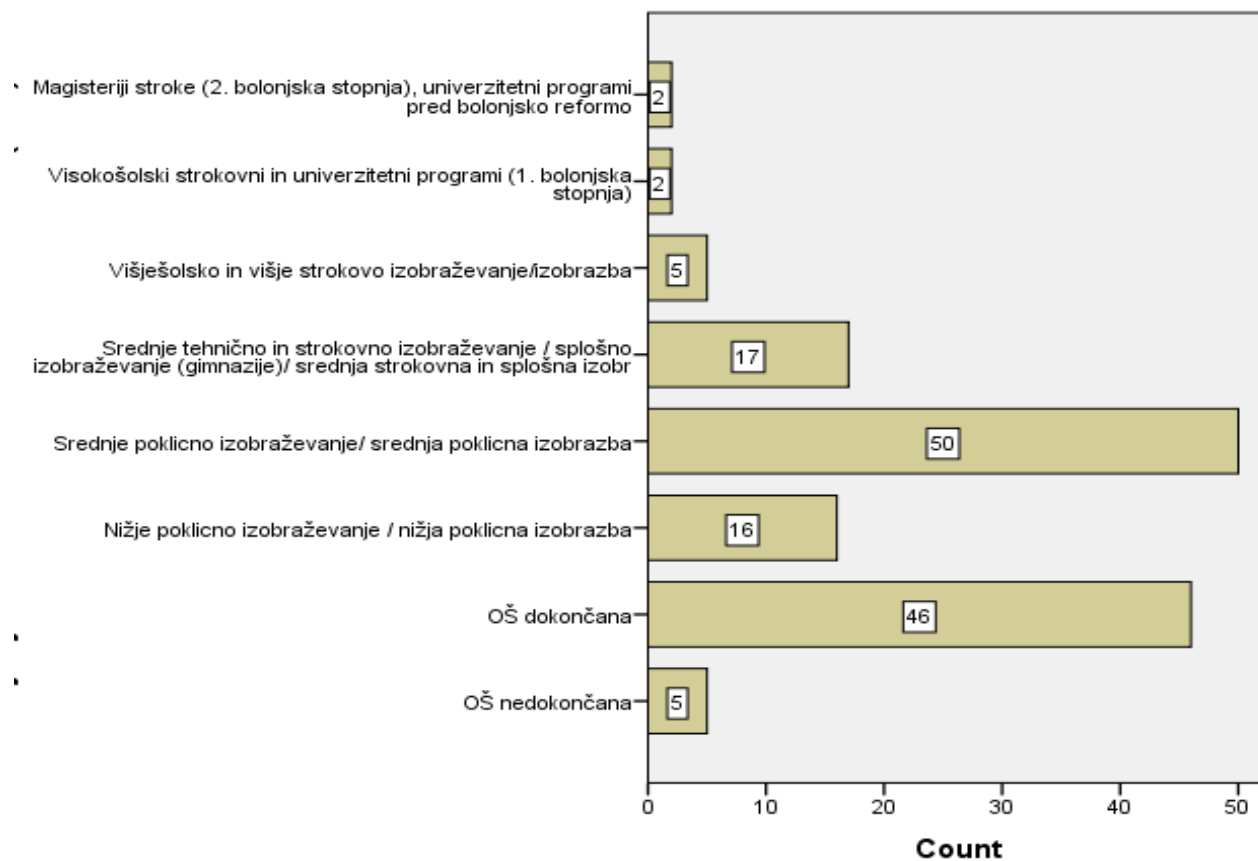


Analyze by gender



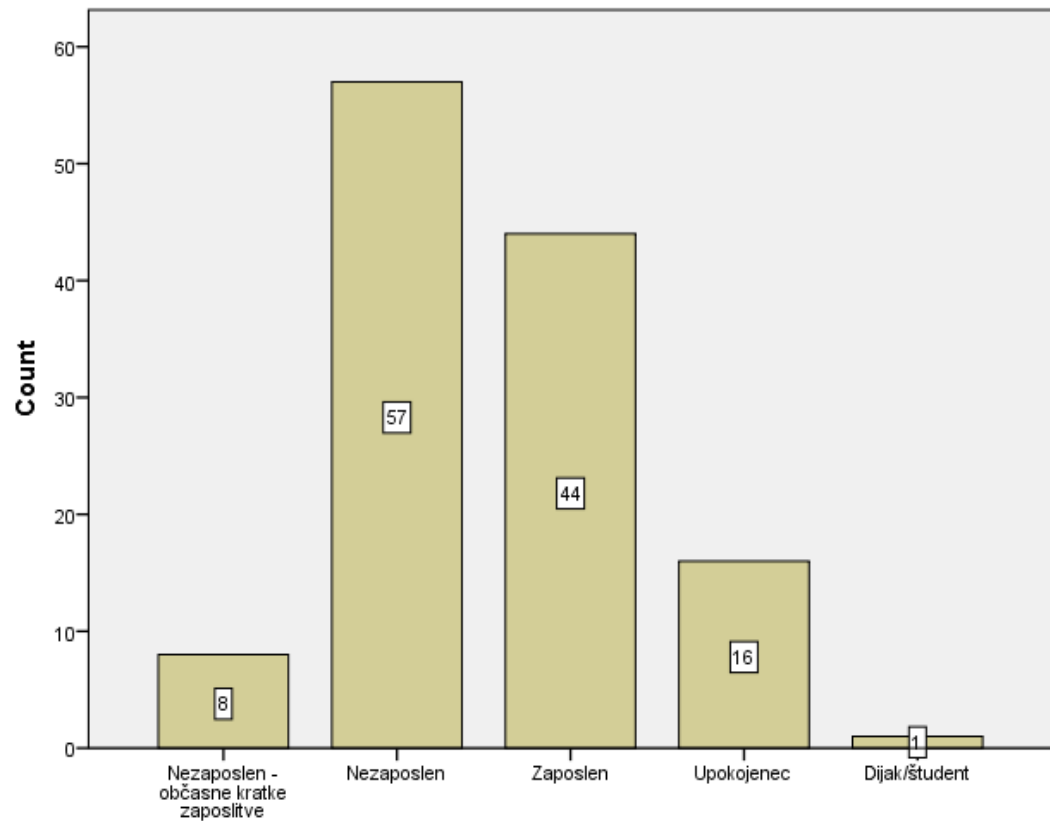

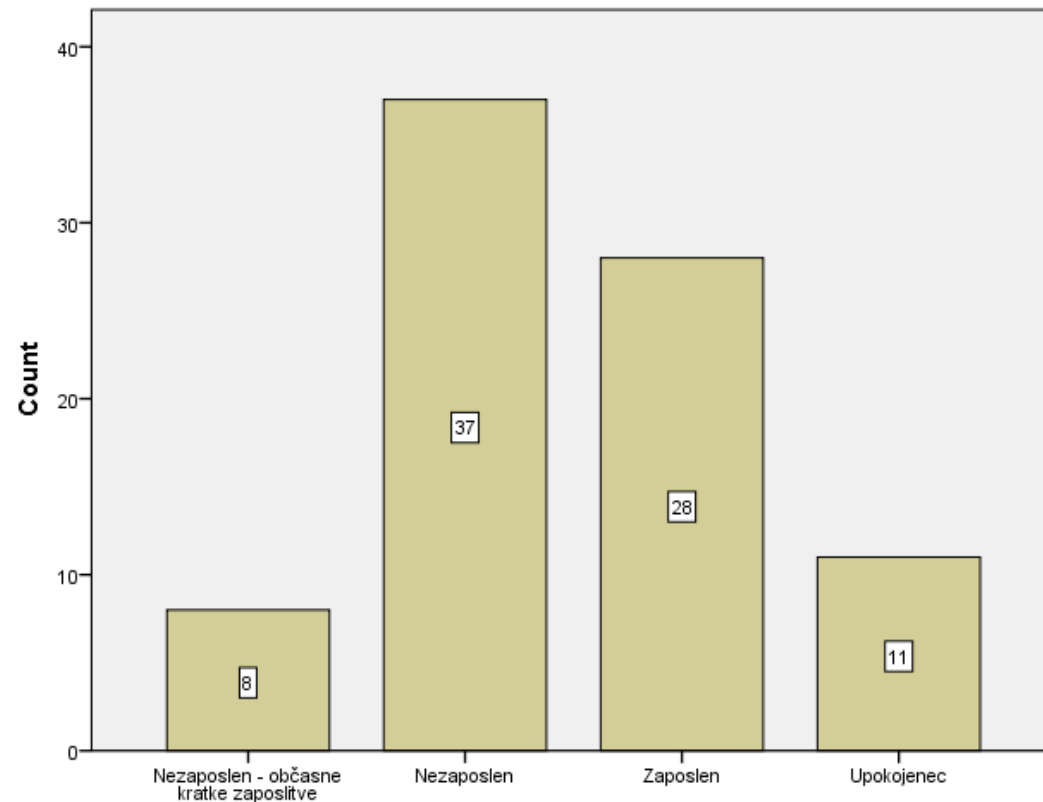

SUSPENDED SENTENCE WITH CUSTODIAL SUPERVISION

INSTRUCTIONS UNDER CUSTODIAL SUPERVISION:

- To submit himself to a course of medical treatment at an appropriate institution, also treatment of alcohol or drug addiction with his consent, (PROGRAMS)
- To attend professional or psychological training, or other consultation,
- To qualify for a job or take up employment suitable to his health, skills and inclination,
- To spend income according to the duties relating to family support,
- Prohibition of association with certain persons,
- Restraining order to keep the offender away from the victim or some other person,
- Ban on access to certain places.

SUSPENDED SENTENCE WITH CUSTODIAL SUPERVISION

- OBSERVATIONS IDENTIFICATION BY PROBATION OFFICERS:
 - 51% PROBATIONER HAVE PROBLEMS OF ADDICTIONS
 - 32% PROBATIONER HAVE PROBLEMS WITH VIOLENCE
 - 51% PROBATIONER HAVE PROBLEMS WITH MENTAL HEALTH

There are no typical features.

Average 45, 25 year of age. From age 20 – 85 year. NO STATISTICAL SIGNIFICAT

Education? Employment?

Who all is the perpetrator? ONLY VIOLENCE?

Programs and measures according to needs probationer.
