










STATISTICS-CONVICTION RATE 2000—2025

























COUNSELLING CENTRE FOR VIOLENCE PREVENTION



-)> Immediate and lasting cessation of violence
-) Increased safety for victims
- » Referral to long—term support (anti—violence—training)



BARRING ORDER AND BAN ON APPROACHING Duration



The barring order and ban on approaching lasts 14 days.




If the endangered person applies for an interim injunction, the barring order and ban on approaching will be extended until the court makes a decision.


However, this can never be longer than 4 weeks.

A court decides the duration of an interim injunction. There is a statutory framework for this.

BARRING ORDER AND BAN ON APPROACHING The police report

If there is a suspicion that a criminal offence has been committed, the police must make a report. This will happen even if the victim does not want it to.





Criminal proceedings reach the criminal court. Then there is an acquittal or a conviction.

BARRING ORDER AND BAN ON APPROACHING Information



The police informs the following bodies about the barring order and ban on approaching:

→ THE COUNSELLING CENTRE FOR VIOLENCE PREVENTION.

Your counselling will take place at the counselling centre for violence prevention. This is mandatory.

→ THE CENTRE FOR PROTECTION AGAINST VIOLENCE.

The centre for protection against violence will actively contact the endangered person. Endangered people receive counselling and support there.

→ THE CHILD AND YOUTH WELFARE OFFICE.

If there are children or teenagers living in the household, the child and youth welfare office will always be informed.



COUNSELLING CENTRE FOR VIOLENCE PREVENTION



From September 2021 to September 2025

- 38.000 perpetrators
- >> 90% male
- >>> Victims:
- >> 80% female

- >>> 20% have to be summoned at least once
- >> 70% complete 6 hours
