#### **What is the Social Participation Table?**

☐ The Social Participation Table (TPS) in the penal and penitentiary area was created by Resolution of the Counsilor of Justice at November 17 <sup>th</sup> in 2005, as an area of relationship between collaborating and volunteer of third social entities and the Secretariat of Penitentiary Services, Rehabilitation and Juvenile Justice.
☐ The regulatory development carried out with the Regulation on the organization and operation of pena execution services in Catalonia (ROFSEPC) of 2006 abounded in institutional collaboration and social participation.
☐ Article 8.3 of the ROFSEPC provided for the creation of TPS in each penitentiary center, called second-level TPS, which are <b>the participation and consultation body</b> of each center.
☐ In order to provide a single regulatory framework for the TPS and second-level TPS, on July 23th, 2009 Order JUS/370/2009 was issued to regulate social participation tables in the criminal and penitentiary area. (which repealed the resolution of the Counsilor of Justice of November 17th, 2005).

# The Social Participation Table in the penal and penitentiary area



#### **Nature of the Social Participation Table**

The Social Participation Board in the penal and penitentiary area acts as a consultative and liaison functional board between the department and collaborating and volunteer social entities with the aim of coordinating citizen participation, as a fundamental right of citizenship.



#### **Functions of the TPS**

- ☐ Provide information and open participation processes with the representation of the social part of the Table in all those strategic aspects of prison policy .
- □ Propose and evaluate the operation and make proposals for improving the general lines, circuits and communication channels that must frame the collaborative relationship.
- ☐ Propose joint strategies to facilitate the dissemination of the social and rehabilitative dimension of prison policy.
- ☐ Any other function related to the previous ones.



#### **Mission**

Recognize professionals and volunteers from social organizations work and establish terms of equal behaviour: IMPROVEMENT OF DIALOGUE

Provide information, open spaces for shared needs diagnosis and generate proposals for improving the intervention: UPGRADE THE INTERVENTION

Propose joint strategies to facilitate the spreading of the social and rehabilitative dimension of penal policy: GENERATION OF FAVORABLE AND POSITIVE PUBLIC OPINION




#### Composition

□ Presidency: the Secretary of Penal Measures and Reintegration <sup>1</sup>

#### **□Vowels**:

- Penal execution:
  - General Director of Prison Affairs
  - Deputy Director General of Corrections and Penal Enforcement in the Community
  - Deputy Director General of Rehabilitation and Health Programs
  - Rehabilitation Service Chief
- Community Action:
  - General Director of Community Action <sup>1</sup>
- Social part: six members of the collaborating social entities and three members of the volunteer ones
- □ Secretariat : Chief of the Open Regime and Social Services Unit

Extraordinary sessions at the request of the presidency or 40% of the members

# Plenary of collaborating and volunteering social entities:

Minimum once a year

# The second-level Social Participation Table in the penal and penitentiary area



#### Nature of the second-level Social Participation Table

The second-level Social Participation Tables in the penal and penitentiary area act as **consultation and relationship boards** between the department and collaborating and volunteer entities with the **aim of promoting social reintegration processes in Catalonia**.



#### **Functions of second-level TPS**

relationship between all parties.

- □ Promote mutual recognition and participation of the involved members and open participation processes with other community resources.
   □ Propose, evaluate the functioning and make proposals for improvement of the general lines of the circuits and communication channels that must frame the collaborative
- □Understand the needs of the prison population as well as propose actions to improve care for groups requiring special attention.
- □ Propose joint strategies to facilitate the spreading the social and rehabilitative dimension of prison policy with the aim of promoting citizen involvement in reintegration processes.



#### **Composition in ordinary regime prisons**

□ **Presidency**: director of the prison

#### □Vowels:

- Penal execution:
  - Manager
  - Deputy Director of Treatment
  - Deputy Director of Inner Regime
  - Multidisciplinary Teams Coordinator or Specialized Care Programs Chief
  - Social Work Programs Chief
- Social part: four members of the collaborating and volunteer organizations
- Municipal mayor of the location where prison is located (or councilor of the district where the prison is situated)

□ Secretariat : person designated as a point of contact for volunteer organizations serving the department responsible for penal execution.



#### Composition in open regime prisons/penal execution in the community

#### □ Presidency :

- In the territorial demarcation of Barcelona: the chief of the Penal Enforcement Support Service of the Barcelona City Management
- In the territorial demarcations of Girona, Lleida and Tarragona: the director of the corresponding open prison

#### □Vowels:

- Penal execution:
  - Directors of each open prison
  - Chiefs of Social Services in the Penal Area in Girona, Lleida and Tarragona; Chief of Support for Penal Enforcement in the territorial services of Terres de L'Ebre
  - Chief of Social Work Programs at the open prison
  - Member of the Treatment Board of the open prison
- Social part: four members of the collaborating and volunteer organizations
- Councilor for Social Services and/or Participation of the city council of the location where the open prison is situated
- □ **Secretariat**: open prison jurist

Extraordinary sessions at the request of the presidency or a third of the members
